

## **Terms and Conditions**

- A confirmation email will be sent upon booking and a reminder email of your appointment day, date and time will be sent 72 hours prior.
- Appointments can be rescheduled at any time up to the cancellation policy.
- 48 hour cancellation policy applies to all treatments. Refunds will not be provided if cancellation notice given after this.
- In the event of emergency situation after the 48 hours notice (bereavement or hospitalisation for example) please phone, message or email Sana Roho as exceptions may be made at the discretion of the business.
- First treatments require full completion of a consultation and consent form which must be returned prior to your appointment no less than 48 hours before your appointment. If your therapist notes any contraindications from your consultation form, this allows a <u>full refund</u> to be issued as it is within the designated time frame. If the form is returned later than the required notice, and your treatment is contraindicated, it is at the discretion of the business as to whether or not partial refund will be issued. This will be emailed to you upon booking. Please note your treatment may not proceed if incomplete/ completed incorrectly.
- It is the responsibility of you, The Client, to ensure you have completed your consultation form to the best of your knowledge. It is extremely important for me, The Therapist to have all necessary information to keep you safe and provide a suitable and safe treatment. <u>No detail is irrelevant!</u> Please refrain from omitting details in a bid to find out if I can 'pick up' on something. Complementary therapies are not intended to have a psychic ability attached to them. It's a bit like sitting in front of your GP and not telling them what's wrong with you- they can't (and won't) pick a diagnosis out of thin air and then treat you (It's also a waste of your hard earned money!) I don't intend on this either. I want what's best for you, so please-full open disclosure. It's all confidential (same as the GP).
